Note: The DD Form 1173-1 is is issued until the member would have been 60 years old, had he or she survived. The DD Form 1173 is is issued only on or after the date the member would have turned 60 years old had he or she survived."

Survivors must promptly report a retiree's death to help avoid delays and possible financial hardship to surviving annuitant beneficiaries, family members or executors who will be required to reimburse any retired pay overpayments. Please follow the steps below to report the death of a military retiree:
