1. <u>Purpose</u>. In accordance with references (a) through (e), this article addresses the proper maintenance of historical unit inactive duty training (IDT) records occurring prior to the full establishment of Enhancement for Drill Management (EDM) in October 2017

## 2. Definitions:

a. <u>EDM</u>. An automated Navy Reserve drill management functionality in the Navy Standard Integrated Personnel System (NSIPS). Provides the Navy Reserve with automated 24/7 self-service drill management capability for managing drill periods.

b. <u>IDT Participation Record, NAVRES 1570/21</u>. Historical form used to manually muster unit drill period participation outside of EDM.

3. <u>Navy Reserve Activity (NRA) Responsibilities</u>. In accordance with references (a) and (c), all documentation that supports financial statement balances shall be retained in the current records management system for 10 years. The Navy Reserve Activity (NRA) will maintain individual unit IDT accounting records for documents prior to the full establishment of EDM in October 2017. Unit IDTs mustered in EDM, and corrective actions taken, are electronically recorded on and stored indefinitely in EDM.

a. Unit IDT Participation Record. Historical records prior to October 2017 will contain:

(1) Completed NAVRES 1570/21, Unit IDT Participation Records.

(2) Unit IDT unadjudicated report with corrective actions taken for unadjudicated IDTs.

(3) NSIPS IDT verification records that were approved, signed, and dated by NRA Commanding Officer or designated representative.

(4) Any additional historical or relevant key supporting documents, already in the current Unit IDT record, such as past earnings statements, designation letters, and unit recall lists.

b. <u>Records Maintenance</u>. In accordance with reference (c), NRAs will use the Navy's authorized records management system for storage of electronic records. NRAs will establish and maintain electronic records in the records management system for each assigned Reserve Sailor, using the naming convention promulgated in reference (c). Local records are authorized and encouraged when the Navy is transitioning records management systems or the systems are inoperable for an extended duration.
