RMKS/1. IN TODAY'S INCREASINGLY UNCERTAIN WORLD MARKED BY GEOPOLITICAL FRAGMENTATION, SOCIAL UNREST, AND UNPREDICTABLE CRIMINAL ACTIVITY, THE RISKS ASSOCIATED WITH FOREIGN TRAVEL ARE A SIGNIFICANT CONCERN FOR EVERY SELECTED RESERVE (SELRES) MEMBER. EVEN WHILE NOT ON ACTIVE DUTY ORDERS AND TRAVELING FOR PERSONAL REASONS, SELRES MUST REMAIN VIGILANT ABOUT THE RISKS OF THEIR OCONUS DESTINATION. THIS SITUATIONAL AWARENESS IS CRUCIAL, NOT ONLY FOR THE SAFETY OF THE SELRES AND THEIR FAMILIES, BUT ALSO FOR NATIONAL SECURITY. FAILURE TO NOTIFY THEIR SECURITY MANAGER ABOUT UPCOMING FOREIGN TRAVEL, REVIEW CURRENT COUNTRY THREAT REPORTS, AND FULLY UNDERSTAND AND FOLLOW THE TRAVEL RECOMMENDATIONS FOR THE INTENDED DESTINATION CAN LEAD TO SERIOUS CONSEQUENCES. THESE MAY INCLUDE DETAINMENT IN FOREIGN COUNTRIES, CONFISCATION OF PERSONAL ELECTRONICS, AND INVOLVEMENT FROM NCIS OR THE STATE DEPARTMENT.

2. IN ACCORDANCE WITH REF A, ALL SELRES MEMBERS WITH NATIONAL

SECURITY ELIGIBILITY, REGARDLESS OF DUTY STATUS, HAVE AN OBLIGATION TO PROVIDE NOTIFICATION OF PERSONAL FOREIGN TRAVEL TO THEIR SECURITY MANAGER AND/OR SPECIAL SECURITY OFFICER (SSO) AT LEAST 14 WORKING DAYS PRIOR TO THEIR DEPARTURE DATE. IF A COMMAND DOES NOT HAVE A SECURITY MANAGER, THE MEMBER SHOULD CONTACT THEIR ISIC'S SECURITY MANAGER. SELRES MEMBERS WITHOUT NATIONAL SECURITY ELIGIBILITY ARE STILL ENCOURAGED TO REPORT THEIR FOREIGN TRAVEL.

3. SECURITY MANAGERS ARE RESPONSIBLE FOR PROVIDING A FOREIGN TRAVEL SECURITY BRIEFING TO ALL SELRES MEMBERS BEFORE TRAVELING OCONUS. THIS BRIEFING WILL INCLUDE INSTRUCTIONS ON HOW TO REGISTER WITH THE SMART TRAVELER ENROLLMENT PROGRAM (STEP) VIA THE DEPARTMENT OF STATE'S INTERNATIONAL TRAVEL WEBSITE (WWW.TRAVEL.STATE.GOV). THE PURPOSE OF THESE BRIEFINGS IS TO HELP MEMBERS PLAN THEIR TRAVEL WITH AWARENESS OF POTENTIAL RISKS. AT A MINIMUM, THE BRIEFING WILL COVER INFORMATION ON TERRORISM AND CRIMINAL THREATS.

4. SECURITY MANAGERS ARE REQUIRED TO MAKE THE APPROPRIATE ENTRIES IN THE DEFENSE INFORMATION SYSTEMS FOR SECURITY (DISS) UPON BEING NOTIFIED OF ANY FOREIGN TRAVEL.
