This message announces Navy Reserve Policy regarding Health

Professions Officer (HPO) Board Certification Pay/Incentive Pay (BCP/IP) eligibility for Selected Reserve (SELRES).

- 2. Eligibility: SELRES HPOs on Active Duty for Training (ADT) for 30 consecutive days or more are eligible for HPO BCP/IP if the below criteria are met.
- a. ADT orders 30 or more consecutive days.
- b. Eligible HPO must have valid credentials through Navy credentialing authority during time of ADT orders in the specialty for which the special pay is paid.
- c. Eligible HPO executed ADT orders practicing the specialty for which the special pay is paid.
- 3. Application: If HPO meets eligibility requirements of paragraph
- 2, the HPO will follow BUMED N1R BCP/IP Standard Operating Procedure (SOP) (reference (e)) found in "BUMED N1R Pillar Library" tab at: private.navyreserve.navy.mil/cnrfc/pillars/BUMED%20N1R.
- 4. Regardless of HPO's reserve billet assignment or location/duty assignment of ADT orders, the requirements of this policy and process described in reference (e) apply.
- 5. SELRES on Active Duty: SELRES HPOs on active duty (Active Duty for Operational Support, mobilization, etc) should follow BUMED guidance posted on
