RMKS/1. Purpose. This ALNAVRESFOR cancels reference (a) and
reinstates requirements in reference (b) to transfer Selected
Reserve (SELRES) enlisted Sailors to the Individual Ready Reserve
(IRR) Volunteer Training Unit (VTU) once appropriate authority has
deemed them an unsatisfactory (UNSAT) participant as defined in
reference (b) while pending administrative separation (ADSEP). This
ALNAVRESFOR will serve as interim policy, effective the date of
release, while reference (c) is updated accordingly.

A. Reference (a) and this message do not apply to or impact cases
involving SELRES officers.

2. Action. Policy in reference (c) no longer applies to enlisted
unsatisfactory participants. All policy regarding the transfer of
UNSAT participants to a non-pay status pending ADSEP will revert
to those published in reference (b) effective immediately. The
changes to the above policies will improve warfighting readiness,
benefit mobilization readiness, and reduce administrative burdens.
Policy in references (d) and (e) remain current and in effect.

3. Immediate Superior in Command (ISIC) points of contact:

A. For questions on participation requirements or documenting inactive duty training (IDT) records, Navy Reserve Activities (NRA) will contact their ISIC N1 staUs.

B. For questions on legal due process or administrative processes due to UNSAT participation, NRAs will contact their ISIC staU judge advocate and legal teams.
