**2. THIS NEW GUIDANCE CONTAINS THE FOLLOWING SUBSTANTIVE UPDATES TO  
THE PREVIOUS GUIDANCE, DATED 6 AUGUST 2026:**

**2.A. PARAGRAPH 5.C. - REMOVED THE REQUIREMENT FOR N31 SCREENING OF  
"EQUIVALENT TRAINING" EXECUTED ON NON-AT/ADT ORDERS IN ALIGNMENT  
WITH RESPERMAN 1571-010.**

**2.B. PARAGRAPH 11 - ADDED GUIDANCE TO SELRES AND NAVAL RESERVE  
ACTIVITY COMMANDING OFFICERS REGARDING THE SCHEDULING AND EXECUTION  
OF DRILLS THAT HAD BEEN CANCELLED OR MUSTERED AS AUTHORIZED ABSENCE  
DURING THE LAPSE OF APPROPRIATIONS FROM 01 OCTOBER 2025 TO 12  
NOVEMBER 2025. IF DESIRED BY THE MEMBER, IDTs CANCELLED OR MUSTERED  
AS AUTHORIZED ABSENCE DURING THE LAPSE OF APPROPRIATIONS SHALL BE  
RESCHEDULED AND EXECUTED NO LATER THAN 30 JUNE 2026.**
