DEFERMENT POLICY UPDATE FOR MEMBERS AFFILIATING WITH

THE SELECTED

RESERVE//

RMKS/1. This ALNAVRESFOR message encourages Sailors (O4 and below

officers; E6 and below enlisted) in Voluntary Training Units (VTU) to affiliate with the Selected Reserve (SELRES) via the VTU to SELRES program.

2. Warfighting ready Sailors continue to support global operational requirements with dedication and professionalism in mobilization billets. As an added incentive to encourage Sailors in the VTU to affiliate as a SELRES in a drilling status, reference (d) authorized a two-year deferment from involuntary mobilization for VTU Sailors affiliating with the SELRES.

3. Program Guidance

a. All eligible officers O4 and below and enlisted Sailors E6 and below in the VTU, who meet satisfactory participation requirements as outlined in Navy Reserve Personnel Manual M-1001.5, may affiliate with the SELRES via the VTU to SELRES portal located on the CNRFC N1

Navy Reserve Homeport (NRH) webpage and will receive a two year mobilization deferment IAW reference (d). Navy Reserve Center (NRC) COs and SELs - poll your VTU populations for interest. Sailors assigned to a VTU, notify your NRC career counselors if you are interested in a two year mobilization deferment to affiliate with the SELRES. NRCs will process VTU to SELRES affiliations, including any HYT waiver requests, directly through the VTU to SELRES portal on the CNRFC N1NRH page located at [https://private.navyreserve.navy.](https://private.navyreserve.navy.mil/cnrfc/N-Codes/N1/CNRFC_N1G2/SitePages/VTU2SELRES.aspx)

b. Effective 1 June 2022, VTU Sailors affiliating through this process will receive a directed assignment from CNRFC N1 as part of this affiliation. Assignments will not exceed the duration of any HYT waiver as appropriate.

c. The Mobilization Availability Status (MAS) code TS1 indicates the member has received the 24-month deferment. Upon affiliation, the gaining NRC will ensure a TS1 MAS code is entered into NSIPS, and track the total time of deferment, removing upon expiration at 24 months.

d. Sailors assigned to a VTU due to HYT will submit a HYT waiver request as part of the affiliation package via the CNRFC N1

affiliation portal located at https://private.navyreserve.navy.mil/cnrfc/N-Codes/N1/CNRFC_N1C2/SitePages/VTU2SELRES.aspx.

VTU members interested in affiliating with the SELRES should work directly with their NRC for an expedited affiliation via the portal.
