- 1. <u>Purpose</u>. Effective October 1, 2022, the Department of the Navy authorizes monetary incentives for Non-Prior Service Enlistments (New Accession Training (NAT)), and Prior Service (PS) Enlistment/Affiliation and Selective Reserve Re-enlistment (SRB). These incentives are designed to encourage enlistment, affiliation, and re-enlistment in designated military career fields, skills, units, or under such other condition or conditions of service for specified periods of obligated service to meet Selected Reserve (SELRES) personnel requirements.
- 2. <u>Policy</u>. All program policies contained in RESPERS M-1001.5, Navy Reserve Personnel Manual (RESPERSMAN) Articles 1100-010, and 1100-020 remain in effect unless amended or amplified in this letter.
- 3. <u>Terms.</u> NAT, Prior Service Affiliation, SRB, and Prior Service Enlistment Bonuses, to include Prior Service Re-enlistment Eligibility-Reserve (PRISE-R), are governed by references (a) through (c).
- 4. <u>Timeline</u>. Award levels decreased by this letter are effective 30 days from the date of this letter to allow processing of excising quotas / pre-certifications letters.

RECRUITING AND RETENTION INCENTIVE GUIDANCE FOR SELECTED RESERVE (SELRES) ENLISTED

1. <u>Introduction</u>. The Department of the Navy authorizes incentive pay for Non-Prior Service Enlistment Bonuses (New Accession Training (NAT)), and Prior Service Enlistment/Affiliation bonuses, and Selective Reserve Reenlistment (SRB) under Title 37 U.S. Code Section 331(a). These incentives encourage enlistment, or affiliation between military services in designated military career fields, skills, units, or under such other condition or conditions of service for specified periods of obligated service to meet Navy personnel requirements. The Navy Reserve shall use the bonus program in the most cost-effective manner to support force management objectives.

- 3. <u>Program Guidance</u>. Reserve incentive program requirements, responsibilities, and policy are found in RESPERSMAN 1100-010, Reserve Incentive Programs. Reserve enlisted incentive specific guidance related to include service obligations, eligibility, and application procedures, are found in RESPERSMAN 1100-020, Reserve Enlisted Incentives.

4. General Enlistment and Affiliation Bonus Initial and Anniversary Payments

- a. NAT, Prior Service Enlistment, Prior Service Affiliation, and Selected Re-enlistment Bonuses will be paid in installments, less taxes. The initial payment will equal 50 percent of the total bonus amount. The remaining 50 percent of the total bonus amount will be divided equally over the remainder of the obligation (either two or five anniversary payments).
- b. Eligibility for anniversary payments is contingent upon the Sailor maintaining satisfactory participation per Navy Reserve Personnel Manual (RESPERSMAN) 1001.5, in the designated rating and/or specialty for each year of the bonus contract.
- c. NAT Enlistment Bonus anniversary payments will be made in five equal annual installments.
- d. Prior Service Re-enlistment Eligibility-Reserve (PRISE-R), Direct Procurement Enlistment Program (DPEP) and Direct Conversion (NAVET or OSVET), must complete requirements to make temporary rate permanent prior to receiving initial or anniversary payments.
- e. In-rate Prior Service Enlisted Bonus and Prior Service Affiliation Bonus anniversary payments will be made annually for two or five-years, based on a three-year or six-year obligation.

- f. All payments are taxable.
- 5. Montgomery GI Bill- SELRES Kicker. Bonus-eligible Sailors who enlist for six years may apply for the Montgomery GI Bill- SELRES Kicker program, provided they meet all eligibility criteria. Reference: Commander Navy Reserve Force Instruction (COMNAVRESFORINST) 1780.1C, Montgomery GI Bill- SELRES Chapter 1606 Basic and Kicker Program Policy Guidance dated 3 March 2011.
- 6. <u>Final Adjudication Authority</u>. CNRFC (N1) is the final adjudication authority for bonus program execution, to include eligibility, termination and repayment. This does not include remission or waiver of indebtedness cases. Any request for remission or waiver of indebtedness will be adjudicated by proper authority in accordance with applicable statute, DoD regulations and Department of the Navy (DON) Guidance.

5. Notes

- a. A sailor shall obtain Naval Aircrew Warfare Specialist (NAWS) designation in order to receive the initial NAT bonus installment.
 - b. Only ratings with "0000" in the NEC column are eligible for PRISE-R bonus.
- c. NEC 0000 (Commonly referred to as "quad zero") is listed to establish that Sailors in these ratings can hold any or no NEC and still be qualified for the bonus provided they meet all other applicable non-NEC related criteria.
- d. A sailor must maintain affiliation with NSW UAS (NSWG 1, UAS-17, or UAS-18) and maintain mobilization readiness in order to maintain bonus eligibility.
- e. Sailors affiliating under a rating conversion program must obligate six years as a drilling reservist in order to receive an affiliation bonus.
